Official Information Act (1982) Request

I write in response to your Official Information Act request, dated 01 November 2018. You requested the following information:

To provide all and any information in its power or control (including information in the power or control of the Northern Regional Alliance, Central TAS, DHB Shared Services, and any other agent of the DHB) concerning, as at today's date,

- **The number of projected unfilled Resident Medical Officer (RMO) positions at the DHB, as of 10th December 2018.**
- **The information requested includes but is not limited to the number of vacant RMO positions in each and every department, and what they are (i.e. House Officer, Registrar or Fellow).**

Please refer to information below (**Table 1**) which provides the list of the number of projected unfilled Resident Medical Officer positions - by site, specialty, position and vacancy FTE, as at 10 December 2018.

In summary, at the date of providing this OIA response, based on current projections for 10 December 2018, Counties Manukau Health will have 23.7 FTE vacant Registrar RMO positions. At this date, there are only Registrar RMO vacancies.
