## Official Information Act Request for – Dental Provider Funding

I write in response to your Official Information Act request received by us 11<sup>th</sup> January 2021, you requested the following information:

"How much in mobile dental provider funding has been provided through the Auckland Regional Dental Service to high school mobile dental providers in the Counties Mankau catchment including but not limited to Lumino Care Dental, Smilecare Dental, West Auckland Mobile Dental Service."

## **Counties Manukau Health Response:**

For context Counties Manukau Health (CM Health) employs over 6,500 staff and provides health and support services to people living in the Counties Manukau region (approx. 574,260 people). We see over 118,000 people in our Emergency Department each year, and over 2,000 visitors come through Middlemore Hospital daily.

Our services are delivered via hospital, outpatient, ambulatory and community-based models of care. We provide regional and supra-regional specialist services i.e. for orthopaedics, plastics, burns and spinal services. There are also several specialist services provided including tertiary surgical services, medical services, mental health and addiction services.

 "How much in mobile dental provider funding has been provided through the Auckland Regional Dental Service to high school mobile dental providers in the Counties Manukau catchment including but not limited to Lumino Care Dental, Smilecare Dental, West Auckland Mobile Dental Service."

The Auckland Regional Dental Service does not hold contracts with providers of adolescent oral health services. We have interpreted your request as, how much does Counties Manukau Health fund providers for adolescent oral health services. Table 1 below reflects the two providers funded for mobile oral health services for adolescents in CM Health under the Combined Dental Agreement.
