Official Information Act Request for - Residential Care Contracts

I write in response to your Official Information Act request received by us on the 29th June 2021 by way of partial transfer from the Ministry of Health (ref: H202106721), you requested the following information:

Can I please request the following information for the South Auckland region:

- 1. The number of service contracts and allocated funding that the Ministry of Health and local DHBs hold or provide for residential home care and home support services;
- 2. The names of the companies that currently receive funding or provide these residential home care and home support services contracts from/to the MoH or local DHB
- 3. The scope of the contracts and funds received (who are the services provided to and where, and the general nature of the services delivered);
- 4. The approximate annual value of the funding and cost of each of these contracts;
- 5. The expiry date of each of these contracts and the years on which the various funding is allocated/received; and
- 6. Primary contact point within the DHB or MOH or funder for each contract

Counties Manukau Health Response:

For context Counties Manukau Health (CM Health) employs over 8,500 staff and provides health and support services to people living in the Counties Manukau region (approx. 601,490 people). The information below covers the Health of Older People, Long Term Supports (Chronic Health Conditions), Short Term Personal Health, Aged Related Residential Care, Community Residential Respite, Long Term Supports Chronic Health Conditions for both Residential Care and Residential Rehabilitation Services.

The approximate annual value of funding for each of the individual companies has not been provided under clause under Section 9(2)(b)(ii) of the Official Information Act as this may prejudice the commercial position of the service which is the subject of the information. An aggregated year to date value at May 2021 has been provided for each overall service category.

Home and Community Support Services – Health of Older People

Scope: Home and Community Support Services (HCSS) is funded for those aged 65 years and over who require care and support associated with age related disability in their homes. Access is via CMDHB Needs Assessment and Service Coordination (NASC) service needs assessment.

HCSS is currently delivered through contracted providers and care is provided by Support Workers in client's homes. The types of care and support provided include:

- Personal Care assistance with activities of daily living i.e. hygiene tasks and mobility transfers etc.
- Household Management e.g. assistance with housework, shopping etc.
- Advanced Personal Care generally assistance with tasks that require contact with blood and bodily fluids i.e. bowel cares

- Household Management e.g. assistance with housework, shopping etc.
- Advanced Personal Care generally assistance with tasks that require contact with blood and bodily fluids i.e. bowel cares

The Aged Residential Hospital Specialised Service (ARHSS) Agreement is an associated national agreement between CMDHB and two aged residential care providers which support provision of residential care for older people at psychogeriatric level care.

Access is via CMDHB Needs Assessment and Service Coordination (NASC) service needs assessment. NB: The Residential Care and Disability Support Services Act 2018 sets out the requirement for all needs assessed residents under the ARRC Agreement to pay a contribution toward their care up to the gazetted Maximum Client Contribution. The 20/21 CMDHB spend against the ARRC Agreement is exclusive of all client contributions required under the Residential Care and Disability Support Services Act 2018.

Scope: The Community Residential Respite Agreement is a local agreement to the national 'Short Term Residential Care Services for People In Contracted Care Facilities' Service Specification. This agreement, between CMDHB and all 43 contracted ARRC providers, supports provision of short term residential care for

older people and people living with chronic health conditions at rest home, dementia, geriatric hospital and psychogeriatric level care. The intent of the service is to provide the full time carer of a person with an older person or a person living with a chronic health condition with an opportunity to have respite from their caring role, to enable them to continue to support the person to remain living in the community. Access is via CMDHB Needs Assessment and Service Coordination service needs assessment.

This agreement, between CMDHB and 28 contracted ARRC providers, supports provision of long term residential care for people living with chronic health conditions at rest home, dementia, geriatric hospital and psychogeriatric level care. The intent of the service is to provide age and support-appropriate residential care for a person living with a chronic health condition. Access is via CMDHB Needs Assessment and Service Coordination service needs assessment.

NB: The Residential Care and Disability Support Services Act 2018 sets out the requirement for all needs assessed residents accessing long term residential care to pay a contribution toward their care. The 20/21 CMDHB spend against the LTS-CHC Residential Agreement is exclusive of all client contributions required under the Residential Care and Disability Support Services Act 2018.
